- An Alberta NUANS name report is also required for named Corporations. This NUANS report must be an Alberta report (not federal), it must be less than 90 days old and it can be ordered in advance or at the same time as requesting the incorporation.
- Please also complete and send a Corporate Search Request Form if you require a NUANS report.
